
# CHAPTER I INTRODUCTION

### A. Background of the Study

"Spoken language usually has certain characteristics; 1) more hesitation, and punctuations and self-correction, 2) no spelling and punctuation conventions, 3) relies on gesture and paralanguage, 3) concrete, fragmented, informal, and context-dependent, 4) characterized by turn-taking."

"However, written language has certain characteristics; 1) more subordination and passives, 2) longer sentences, 3) more explicit coding of logical relations, 4) less modal modification, 5) structurally elaborate, complex, abstract, and formal, 6) characterized by monologue<sup>2</sup>."

Language that internasional community chooses is English inashmuch as it is used by many people around the globe. The language used by many people in many countries to comminicate with each others call linguafranca. English is linguafranca. People who want to study, work or do business with or in foreign contries have to be able to master English well.

All of things used english. English is used in many fields and aspects including business, knowledge, science and technology, and also information and journalism. According to its media and publication

Printed journalism is journalistic process whose result of reportation is written and published on printed media such as newspaper, magazine, and tabloid. Its writing technique uses written language and language of mass media whose characteristics are; briev, simple, unambiguous, and familiar.

Electronic journalism usually called broadcast journalism is journalistic process whose result of reportation is published by means of radio and television. Radio news only uses soud and auditory whereas television news adds with visual. Television and radio writing-script technique uses spoken language, word combinations used in daily conversation, simplicity, easy to understand, brievity, and clear.

Online journalism (cyber journalism) is journalistic process whose result of reportation is published by internet or cyber media. Its writing technique is as same as printed media is(using written language),nevertheless, its writing script is more free and can be more complet than printed and electronic mediascript<sup>3</sup>.

Making a good writing work like in journalism, the writer must be able to transform her/his idea into written language. S/he must also be able to convey her/his idea. It means that if the readers read her/his writing, s/he will understand it. Writing is one of subject studies af English department in Tarbiyah Faculty at IAIN Walisongo. It means that writing becomes one of important materials in English teaching. As an English teachers, we must know more knowledge of writing which will be given to students.

The English grammatical collocation is a part of writing aspects which will give essential impact if we understand it inasmuch as essential material in writing English language. Non-native English writers usually ignore it because of their limitation of knowing it. It can not think logically because it is arbitrary by native English. Even though it is essential, there are many non-native English writers or students tend to forget it so that native English speaker will reject their writing in account of the fact that it is strength.

According to the explanation before, it is clear why the writer wants to find out the way to make advanced writing by concerning on writing elements. In this thesis, the writer focuses his research on English grammatical collocations.

# B. Reason for Choosing Topic

English student can improve their knowledge of english grammatical collocation in order that they can make advanced writing like journalist of *The Jakarta Post* whose writing works are communicative and advanced.

The study is expected to provide and add some informations which can help the teacher to improve their skill in writing, hance, the native speaker of english will not reject their writing in view of the fact that the teacher has understood how to write well by using English grammatical collocations.

By reading this study, the reader will get a lot of informations, especially how essencial English grammatical collocations in forming advanced writing. The reader will be easy to write their idea and knowledge in written language on account of the fact that the reader has got new knowledge of transforming his/her idea in English advanced writing convidently.

By doing this research, the writer gets additional experience and knowledge of advanced writing and printed journalism including newspaper.

## F. Definition of Key Terms

The writer needs to clarify the key terms of the study to avoid misunderstanding and misinterpreting between the reader and the the writer. The writer will describe the definition of key terms used in the tittle of the thesis.

Identifying comes from the word '*identify*'. It means say, show, prove who or what somebody or something is. In this study, identifying means to show the English grammatical collocation found in *The Jakarta Post*.

The Jakarta Post is an English written newspaper published in Indonesia which has communicative and advanced writing. It is one of printed journalism and absolutely there are many knowledge of writing

which we have to concern on it such as writing aspects, language style, brievity, etc.

English collocation is divided into two kinds. The first is English grammatical collocation and the second is English lexical collocation. The writer in this occasion only focuses on English grammatical collocations. He does it in order that it can be focused and will give maximum result and understanding for all.

English grammatical collocation is a phrase consisting of a dominant word (noun, adjective, verb) and preposition or grammatical structure such as an infinitive or clause. Native speaker of English is sensitive when finding writing work that violences English grammaticall collocation. Usually they will fell that the writing work is strange.

Contribution is an item to be included. It means that the writer in this study will make an effort to get important items to be included in a teaching writing as the object of the study after he makes identification of kinds of English grammatical collocation and purposes of using each grammatical collocation in *The Jakarta Post*. After determining the results of identification, he used the available syllabus at English department.

Writing course is the series of a lesson in which writing becomes a subject study. It is aimed at preparing knowledge about basic principle of writing. Teacher gives writing knowledge, showing how to do it, and instructing the students as the teacher's idea. Teacher's ideas related to the teaching proces, especially at teaching models.

Because writing is one of the four skills which is the most complex skill to learn, teacher should take seriously the writing exercises in the course book that they use in the classroom. The teacher should examine whether the writing exercises in the course book could improve the writing skills and meet the requirement of good writing tests and they should

observe whether the writing exercises in the course book could lead student to the goal as stated in curriculum or not.
