CHAPTER I

INTRODUCTION

A. The Background of Research

Education is a conscious effort to prepare the students through guidance, teaching and or exercise for its role in the future. In general, education can be interpreted as a process of the assistance provided by adults to children who have not yet adults to achieve maturity.¹

Starting from the understanding above, a good and ideal education activities should include the field of guidance and teaching. According to WS. Winkel, Guidance means "giving assistance to a person or a group in their adaptation to the demands of living".² With the existence of this help, a person can eventually resolve himself the problem faced in next day is the purpose of the guidance.

In the conventional class, teacher sometimes doesn't understand all students' characters so that only some students get special attention, expecially they are known as smart, stupid and naughty. This causes the students who are considered at the middle (they are not smart, stupid and naughty) don't get attention.

The teacher has role as teacher in the school. The role and guidance of the teacher really determine in the process of growth and development of students. The interaction between teacher and students as the main meaning in teaching process takes an important role to achieve the goals of effective teaching. The teacher must be able to develop, create and manage the situation that allowes students to learn well. This means that teaching is the process and its goal is to grow and encourage the students to do the learning process and provide assistance to students who have difficulties in learning.

Integrity of interaction between the process of students learning and teacher teaching can be success when the results of student learning are better expecially in knowledge and understanding, behavior, skills and ability. The implications of the results of good teaching must be thorough. It means that it is not just mastery of knowledge but it also appeared in the change of attitude and behavior. Therefore teaching is a professional work. It is not part time work or additional work. The responsibility of the teacher is great against the success or failure in teaching students. Therefore teacher must really understand that he is teacher and mentor who has knowledge. Islam appreciates those who have the

knowledge, this is mentioned in Quran by Allah SWT Surah Al-Mujadalah Verse 11:

Environmental changes from the family to school have children to experience problems. it includes difficulty in adjustments themselves when the learning process is in progress. Many of them experience difficulty in understanding the lessons, working tasks and planning timetable. From hadist above, it mentions that the childreen need guidance of two parents. Because of that, the guidance is very

- 3. How is achievements of students who got learning guidance in academic year of 2015/2016 and who didn't get it in academic year of 2014/2015 in English lesson at class VIII in MTs Ribatul Muta'alimin Pekalongan?

D. The Objectives of Research

The objectives of the research are as follows.

- To identify whether there is the effect of learning guidance to achievements of students in English lesson at class VIII in MTs Ribatul Muta'alimin Pekalongan in academic year 2015/2016.
- To know how is the learning guidance done to the students at class VIII in MTs Ribatul Muta'alimin Pekalongan in academic year of 2015/2016.
- 3. To know the achievements of students who got learning guidance in academic year of 2015/2016 and who didn't get it

in academic year of 2014/2015 in English lesson at class VIII in MTs Ribatul Muta'alimin Pekalongan.

E. The Pedagogical Significant

The results of this research can contribute to the effectiveness of the teaching and learning activities so that the results of teaching and learning activities can be optimal.

- As the material of information about the implementation of learning guidance for improving the achievement of students.
- As a discourse to motivate teachers to be more focused and serious in giving learning guidance So it can create maximum results.

d. For Institutions

This research can give input to the MTs Ribatul Muta'alimin Pekalongan in implementation of learning guidance in schools so that students are able to get better achievement.
